

25 Years of Serving the Community



1987 – Several churches joined together to plan the formation of a Co-op ministry with a mission to provide services to low income and homeless families in the Norcross area.

1992- NCM opened its first clothes closet.

1993 – NCM assisted other communities in establishing their own facilities.

1999— A total of 20 churches become financial partners and over 100 volunteers assisted with serving the community.

2002—Land was acquired from the city of Norcross and with financial donations from many investors, a mortgage was obtained to construct NCM's first permanent facility.

2006– The mortgage for the NCM building was paid off and dollars saved were used for additional client assistance.



2007– Over 200 dedicated volunteers were serving every week at NCM.

2011– The staff and NCM board completed a five year strategic plan to focus on fundraising and program expansion. The feasibility study began for the Restoring Hope! campaign.



2012– First Community Development, a campaign staff and hundreds of volunteers began the Restoring Hope! campaign.

2013—Restoring Hope! campaign completed successfully.



Restoring Hope! Campaign Success

Norcross Cooperative Ministry began the Restoring Hope! initiative in August 2012. It's purpose was to underwrite a new five year program to help those in need in the greater Norcross area showing families a pathway to life transformation from poverty to economic responsibility. At the conclusion of the campaign, \$3.5 million was invested by 235 supporters over the next five years. Through Restoring Hope!, Norcross Co-op will implement three programs that will benefit the Norcross area:

- Transforming Lives
- Provide New and Expanded Services
- Educate and Communicate



Restoring Hope! In action



Marseilles Payne is a single mother with two children (8 year old daughter and 18 year old son). Back in the summer of 2013, she lost her job. Although she had a college degree, she found herself without a job and all of her savings were gone. Not only were bills and rent due, but to obtain future employment, she had to renew her national certification to continue to be a medical assistant. Marseilles was referred to the NCM for assistance. At first, it appeared that the Coop would not be able to help her but we listened and treated her with dignity. Although she found another job quickly, Marseilles and her family were evicted from their apartment and started living in their car.

After working with Marseilles for several weeks, it became apparent she would be a good candidate for the Transforming Lives Program (TLP). NCM decided to pay for her recertification so that she could keep her job and put her into a hotel after the eviction. "While I was thankful that NCM helped me stay in a hotel, I wanted so bad to move my children out as quickly as possible." It finally happened in March. Marseilles and her two children were accepted in the Impact! Transitional Housing Program in March and moved into a three bedroom apartment. (*Pictured on the right*.)




